
Understanding Criminal Typology: New trafficking route in west Africa

- Crossing borders without passports or ID cards
- Young girls of 18 years

The Proactive Measure by AU: Continental free movement of Persons Protocol



Continental Approach of African Union

- Mobility, Migration and Trade Facilitation
- 55 Member States
- Unified States through Integration and Development
- 32 countries ratified the protocol
- Decision reached on Borderless States in 2016
- African Union Integrated Border Governance Strategy: Adopted in 2020
- Development of Capabilities for Border Governance

African Union attempt to create seamless border in Africa



- West Africa: Benin Nigeria (Joint Border Post at Seme Karake); Togo
 Burkina Faso (Border post at Cinkanse)
- East Africa: Kenya Tanzania (Namanga Namanga border); Rwanda –
 Democratic Republic of Congo (Rubavu Goma Border Post)
- Southern Africa: South Africa Zimbabwe (Beithbridge); Zambia –
 Zimbabwe (Chirunda Border)
- Central Africa: Cameroon Gabon Equatorial Guinea (Kye Ossi Border Post); Congo – Democratic Republic of Congo – Angola
- Horn of Africa: Djibouti Ethiopia border post; Kenya Ethiopia (Moyale Border Post)

New Regional Efforts to ease mobility and ensure security



- The Concept of Border Areas Adopted by Heads of State and Government in 2006
- Recognized border Communities as building blocks for regional cooperation and integration
- Moving away from ECOWAS of States to ECOWAS of People
- Trans-National Identities (creating borderless society)
- Establishment of National Platform for Cross Border Cooperation
- Cross Border Corridors K2M, GHATOBEN, Mfum- Ekok.

Some Challenges of African Borders



- Incomplete demarcation of borders and/or lack of knowledge of the border limits
- Lack of Synergy between the levels of Governments
- Porosity of the borders
- The Center-Periphery Dichotomy and the Challenges of Development Marginalization and Ungoverned spaces Challenges of Joint Projects
- Maintenance of facilities like provision of electricity/generating set and fueling
- Supply of water
- Source of funding to include local communities of both sides
- Trans-border crimes
